



2024-2025 Dependent Verification Worksheet

CFK must compare the information on your FAFSA to either the **2022 IRS Tax Return Transcripts OR the SIGNED copy of the 2022 tax return and all schedules** and/or with W-2 forms and/or other financial aid documents. If there are differences between your application information and your financial documents, your FAFSA may be corrected. Also, we may request additional information. You and your parent must sign and complete the worksheet, attach any required documents, and submit to the Financial Aid Office.
