

### What is FAFSA?

Free Application for Federal Student Aid

A student may qualify for:

- Federal Pell grant
- Work-study funds
- Direct Loans

Most scholarships require a FAFSA to be on file.

#### **Creating An Account**

- New Students & Parents: Create FSA Account
  - $_{\odot}$   $\,$  It may take up to 24 hours for FSA to verify your account
- Parents & Contributors who do not have an SSN can create an FSA Account
- Returning Students & Parents: Log in to your existing FSA account
  - If you have ever set up an FSA account, the system will ask you to log in using either security questions or the email address associated with your account

## **Creating An Account**

#### Section 5: Acceptable Identification Documents

All acceptable documents submitted for verification or proof of identity must be valid (current and unexpired). The name of the individual and address on the utility bill must match the information provided on this form. Only one (1) document is required from Group A or two (2) documents from Group B.

#### Group A

- U.S. State/Territory Driver's License
- U.S. State or City Identification Card
- Foreign Passport


Group B: Utility Bill [1] plus one (1) of the following:

- Municipal identification card
- Community ID
- Consular identification card


<sup>1</sup>A utility bill is generally defined as a monthly statement that details an amount owed by an individual(s) of a household for basic services that keep a residence operable. Such as: electricity, water/sewer, gas, trash/ recycling, television, internet, or phone bill.





#### Date of Legal Residency

Enter or select the month in the "Month" field. Use the "mm" format if typing. For example, August should be entered as "08."

Enter the year in the "Year" field in "yyyy" format. For example, enter "2015" instead of "15."

Your state of legal residence will use this information to determine if you meet its criteria for state financial aid.


A student may be experiencing unusual circumstances if they

- left home due to an abusive or threatening environment;
- are abandoned by or estranged from their parents;
- have refugee or asylee status and are separated from their parents, or their parents are displaced in a foreign country;
- are a victim of human trafficking;
- are incarcerated, or their parents are incarcerated and contact with the parents would pose a risk to the student; or
- are otherwise unable to contact or locate their parents.

If the student's circumstances resulted in not having a safe and stable place to live, they may be considered a homeless youth and should review the answer to the previous question about being unaccompanied and homeless.

#### High School Completion Status When the Student Begins the 2024–25 School Year



- "High school diploma" means the student has received or will receive a U.S. high school diploma or a foreign school diploma that's equivalent to a U.S. high school diploma before the first date of their enrollment in a college or career school.
- "State-recognized high school equivalent (e.g., GED certificate)" means the student has received or will receive a General Educational Development (GED) certificate or state authorized high school equivalent certificate, such as the High School Equivalency Test (HiSET) or the Test Assessing Secondary Completion (TASC), before the first date of their enrollment in a college or career school. A state authorized high school equivalent certificate is a certificate that the issuing state recognizes as the equivalent of a high school diploma in that state. Note: A high school certificate of attendance and/or a certificate of completion are NOT the equivalent of a high school diploma.
- "Homeschooled" means the student completed home schooling at the secondary level regulated by their state.
- "None of the above" means the student doesn't have a high school diploma or state- recognized high school equivalent and didn't complete secondary school in a home school setting.


